RESOLUTION NUMBER: 4 -2019 AN ADDITIONAL APPROPRIATION FUNDING THE START OF A FLIGHT SCHOOL

WHEREAS, it has been determined that it is now necessary to appropriate additional sums in furtherance of the Jasper County Airport Authority's establishment of a Flight School, which sums were not appropriated in the annual budget;

WHEREAS, Resolution 3-2019, first adopted on July 3rd, 2019, and later reaffirmed by all JCAA board members on July 24, 2019, approved an additional appropriation in the amount of \$75,000, \$72,000 of which would go into the flight school fund for aircraft acquisition, initial maintenance, fuel and supplies; and the remaining \$3,000 going into the operating fund insurance line item to fund additional insurance required for the flight school.

WHEREAS, following the recommendation of the Department of Local Government Finance (DLGF), State Board of Accounts (SBOA), and financial advisors, it has been determined that a better way initially fund the flight school is by appropriating the expenses under the airport operating fund and depositing revenue into the flight school fund until such time that the flight school fund has sufficient revenue to cover annual flight school operating expenses.

Section 1: Be it resolved by the Board of the Jasper County Airport Authority, City of Rensselaer, County of Jasper, State of Indiana that the sums originally appropriated under Resolution 3-2019 will be updated to the following; and that the following sums of money are hereby appropriated out of the funds named and to the funds named, subject to the laws governing the same:
